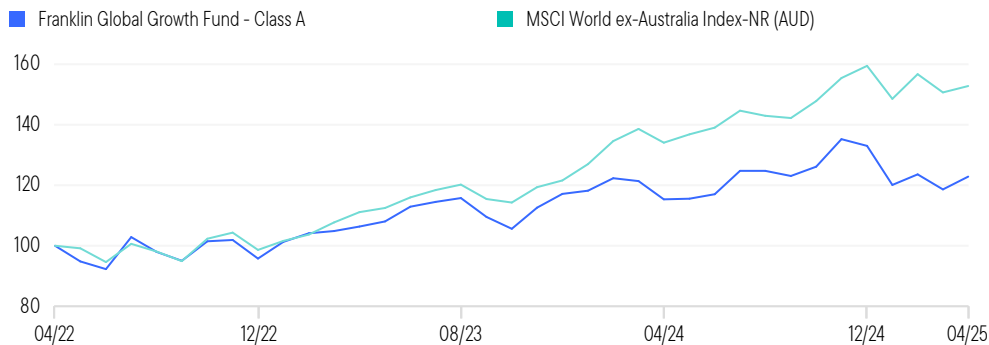
Investment Overview

To out perform the MSCI World ex Australia Index-NR, in Australian dollar terms after fees and expenses (but before taxes), over the medium to longer term.

Fund Highlights
